## Family requirements when participating in a CISV Program

1. Families must be CISV Saskatoon members. Membership is \$75 per family per year and can be purchased on our website <https://cisvsaskatoon.org>.
2. Delegates must attend at least one local CISV activity before attending the international program. This could be a minicamp or community involvement activity. The more experience your child has with our organization before their international program the more prepared they will be for it.
3. One parent must attend the first delegation meeting with your child in April (September for Winter Programs). We will contact each delegation family and pick a date that will work for everyone.
4. Attend 5-10 delegation meetings between April and the program (September for Winter Programs). This will be at the discretion of the delegation leader. The more times the delegation can meet the more prepared they will be for their program. Past participants and their parents suggest to meet together as a delegation as many times as possible before the program.
5. Offer to host at least one delegation meeting in your home. This will allow your child to act as the “host” of the meeting. It will also make it fair if each family takes a turn to host instead of always meeting at the same location.
6. Fill in Health and Legal forms for your child and get them in early. Your delegation leader will explain and give you the forms that need to be filled in before your child departs for their program. You must follow the deadline your leader sets.
7. Collect Canadian items to take to your program to share with new friends: pins, key chains, magnets, etc. Most camps will ask you to bring some posters to decorate the camp site. This can also help the delegation explain what their country is like. The delegation will be preparing a national presentation during their meetings and may require your support in collecting needed items for their presentation (examples could be: maple syrup, mini hockey sticks, dream catcher supplies)
8. You will be asked to attend the “Bon Voyage” (June/November) and “Welcome Home” (September/March) activities planned by the chapter, We encourage the entire family to attend and feel free to invite friends, grandparents and any people who are important in your child’s life.
9. Upon return we ask that each delegate do a presentation to their class, church or another group they are involved with to promote the program to potential new participants. This also gives your child a chance to digest their experience and encourage the generalization of their experience and how they can apply it to their life at home.
10. Any concerns with your program can be brought to your delegation leader. If you feel that you cannot approach your delegation leader regarding the problem please contact CISV Saskatoon.
11. To apply for Seminar Camp please request a separate application form.
